

Message from the Patron

Pakistan Society of development Economists (PSDE) as a professional association of economists has been providing a platform for exchange of ideas on the economic and social problems facing the country. Presently, Pakistan faces many daunting challenges. The balance of payment situation remained precarious owing to the expansionary macroeconomic policies during the last two years. The higher spending pushed the budget deficit to over 6% of GDP in 2017-18 through increased borrowing from abroad raising pressure on the current account deficit and external debt. As a result, imports soared rapidly with declining exports registering historically the highest trade deficit of \$31 billion along with the current account deficit of \$18 billion or 6% of GDP in the last fiscal year. The higher borrowing to finance the current account deficit has escalated Pakistan's external and public debts. Consequently, country's total debt and liabilities increased to Rs29 trillion by June 2018 or 86% of GDP which is well above the debt sustainability limit set by the government. The regaining macroeconomic balance is the foremost objective and priority of the newly elected government.



Regional connectivity is the philosophy behind the development of China-Pakistan Economic Corridor which is a linchpin of China's Belt & Road Initiative. Despite surrounding uncertainty, the CPEC has a great significance in the context of regional connectivity, diverse investment opportunities, industrial, and financial cooperation, and poverty alleviation through increased opportunities for livelihood. Over the past few years, the performance of agricultural sector has been dismal with its adverse effects on the employment and the economy. The country has not benefited from agriculture which is vital for the economy and livelihood of the poor. The framework of CPEC is now expanded to boost-up agriculture and related sectors of economy in the interest of the people in an environmentally sustainable manner. Both China and Pakistan will promote comprehensive cooperation in agriculture in the field of high technology, research institutes and agricultural enterprises by investing in high value added agricultural products. Both countries will strengthen and enhance the trade of quality agro-products, remove the trade barriers, technical barriers to trade and sanitary & phytosanitary for the promotion of agri-business.

The government is committed to play a pro-active role by paving the way for private sector led growth which can be done by focusing on improving value chain competitiveness in targeted areas. Joint ventures, value addition, cold chain management for fruits and vegetables, marketing and branding will help country overcome weaknesses, increase country's agriculture exports and improve socioeconomic conditions of the poor and vulnerable groups in rural areas.

Finally, I appreciate the PSDE for continuing its custom of organizing the Annual Conference and AGM to provide policy guidelines to policy makers. I hope that this years' conference will generate a critical debate on the state of the economy and provide informed policy options for the social and economic challenges facing the country.

PAKISTAN'S ECONOMY: THE WAY FORWARD

Welcome to the 34th Annual General Meeting and Conference of Pakistan Society of Development Economists (PSDE). This year's overarching theme of the conference is 'Pakistan's Economy: The Way Forward'. The AGM and conference of PSDE is a regular event taking place since 1984 under the umbrella of Pakistan Institute of Development Economics, the Pakistan's premier think tank, policy research institute and university. This year's conference includes 5 distinguished lectures, 6 panel discussion sessions, 8 parallel technical sessions and the inaugural session.

Pakistan economy is facing many economic and development challenges and the present government is struggling hard to cope with these challenges. These challenges include trade and current account deficits, climate change, water security, regional connectivity and health issues. This year's conference of PSDE contains dedicated distinguished lectures and panel discussion sessions revolving around these current policy issues. World leading professionals are invited to take part in the debate. This year's distinguished guests include Dr. Adil Najam, the lead author of report of Intergovernmental Panel on Climate Change, the report that won 2007 Nobel Peace Prize. For Allam Iqbal Lecture, we have Pakistan's leading economist Prof. Syed Nawab Haider Naqwi who will be talking about defining movements and ideas in economics and For the Quaid-e-Azam memorial lecture, we have Dr. Tariq Banuri who is current Chairman of Higher Education Commission and world renowned environmental scientist and economist who will be talking about An Export Promotion Strategy for the Knowledge Economy.

The objective of the 34th AGM and Conference of PSDE is to evaluate the prospects of the economy and suggest the viable solutions and the way forward which would be helpful in setting policy direction to achieve a higher growth trajectory in terms of economic as well as human development in the coming years. Sub-themes of the conference are, but not limited to the following:

Expanding on some of the above sub-themes, agriculture is the lifeline of the economy employing the largest proportion of country's workforce and providing raw material for several value-added industries. Revitalization of Agriculture can play a central role in national development, food security, employment generation, and human development. The industry is the backbone of the economy but remained vulnerable to factors such as government policy changes, trade agreements, finance and infrastructural limitations, foreign direct investment, un-skilled workforce, lack of research and innovations, and energy supply. Strategically, a prosperous industrialized Pakistan can be created through building infrastructure, creating an incentive structure designed to achieve a competitive, dynamic, and export-driven industrial sector capable of providing decent employment to the growing labor force. Pakistan also faces the challenges of declining water availability and its quality, growing water pollution, and environmental insecurity. A combination of factors, including global climate change, local waste and water mismanagement has led to a rapid depletion of water supply. The supply demand gap is persistently increasing with compounded effects of climate change on snowmelt, reducing flows into the Indus River, the primary fresh-water source for the country. In a country where economic growth is largely driven by agriculture, scarcity of water will have serious consequences for the employment, poverty, inequality and living standards of the population. Regional connectivity through China–Pakistan Economic Corridor (CPEC) provides a great opportunity with the \$62 billion of financing equivalent to 20% of country's GDP which augurs well for growth, industrial development and human development for both China and Pakistan. In this regard Trade Prospects and Opportunities and Challenges for Freight Transportation can be explored. In this age of fast communication technological advancement, the media can play an important role in reshaping preferences and social norms within societies. By publicizing information that is reliable and relevant for citizens, the media can contribute effectively towards government policies, project and programs.


Profiles of Speakers, Panelists and Guests

Makhdum Khusro Bakhtyar

Makhdum Khusro Bakhtyar is a member of the National Assembly of Pakistan and Federal Minister for Planning, Development and Reforms. He is also patron of the Pakistan Society of Development Economics and Chancellor of Pakistan Institute of Development Economics. He has held the seats of Punjab Assembly and National Assembly and he held the portfolio of Minister of State for Foreign Affairs.



Mr. Bakhtiar graduated from the University of Punjab in 1990, and received an LLB degree from the London School of Economics and Political Science and a Bar-at-Law degree from Lincoln's Inn United Kingdom.



Dr Asad Zaman

Asad Zaman is member Economic Advisory Committee of Prime Minister of Pakistan, Vice Chancellor Pakistan Institute of Development Economics, President Pakistan Society of Development Economists. He also serves as member Monetary Policy Committee, State Bank of Pakistan and Director, PSLM and HIES Surveys, Federal Bureau of Statistics, Pakistan.

Before joining PIDE, he has taught at top rank institutions including International Islamic University of Islamabad, Lahore University of Management Sciences, Bilkent University Johns Hopkins University, Columbia University, University of Pennsylvania, Applied Economic Research Center, University of Karachi, California Institute of Technology, Center for Belgium and International Monetary Fund. He has been elected council of the Econometric Society.

Dr. Zaman has excellent command over the history of social and economic thought and historical development of western political thought. He refutes the western methodology of social sciences with undeniable evidences and considers that Islamic heritage in social sciences is far better than western counterpart. He is strong advocate the superiority of Islamic Social Sciences.

Dr Zaman has written extensively in top economic and econometric journals including Annals of Statistics and Journal of Econometrics. 
Dr Tariq Banuri

Dr Tariq Banuri has broad experience in government, academia, civil society and the international system. He started his career in the Civil Service of Pakistan, went on to receive a PhD in Economics from Harvard University, and joined the United Nations as a Research Fellow at the WIDER. Dr. Banuri was member of Steering Committee on

Higher Education Reforms, the body that played a vital role in inception of HEC in 2002. He has also remained member of the Board of Governors, State Bank of Pakistan, member of the Pakistan Environmental Protection Council and worked as Coordinating Lead Author on the Nobel Prize winning Inter-governmental Panel on Climate Change (IPCC). He has been providing free consultative services to Pakistan government in the area of climate change and to Mehran University in the area of water. Dr. Banuri holds a PhD degree in Economics. He did his Bachelors in Civil Engineering from University of Peshawar and Masters in Development Economics from Williams College.



Dr Syed Nawab Haider Naqvi

Prof Syed Nawab Haider Naqvi is a Professor of Economics at Virginia Tech, USA and at Federal Urdu University of Arts Science and Technology, Islamabad. He has been Director PIDE for a long tenure and have inevitable role the development of PIDE. He is also the Founder President of Pakistan Society of Development Economists. He held the positions of Senior Economic Adviser, National Electric Power Regulatory Authority (NEPRA), and Economic Adviser, MCB Institute for Development Research, Chief, Economic Affairs Division, Government of Pakistan and Rector of Kausar University of Sciences, Islamabad

He has been a Member, National Geographic Society, Washington, Chairman, Committee for the Eighth Five Year Plan, Government of Pakistan, Chairman, and Member Board of Management, Asia and Pacific Development Center, The United Nations, Kuala Lumpur, Chairman and Member, Asian Sub-Link Project, ESCAP, Bangkok, and Chairman, Committee on Islamization, Government of Pakistan. He has received Sitara-i-Imtiaz (1991), ECO Award for outstanding performance in the field of Economics (1992), Lifetime Academic Achievement Award, (2005–2006), Lifetime Award for Kanati Institute of Russia (2001–2012). His area of research include Development Economics, International Economics, Agricultural Economics, Comparative Economic Systems and Econometric Model-building. He received his master's degree from Yale University and his doctorate from Princeton University.

Dr Adil Najam

Dr Najam is the Inaugural Dean of the Pardee School of Global Affairs at Boston University, where he is also a professor of international relations and of earth and environment. Former Vice Chancellor of LUMS, he has also been a professor of negotiation and diplomacy at the Fletcher School of Law and Diplomacy, the Director of the Boston University Center for the Study of the Longer-Range



Future, and taught at MIT.

Author of over 100 scholarly papers and author or editor of over a dozen books, Dr. Najam was a lead author for the third and fourth assessments of the Intergovernmental Panel on Climate Change (IPCC), work for which the IPCC was awarded the 2007 Nobel Peace Prize. 


He holds Master degrees in Psychology and Public Administration from the Harvard University and Masters in Public Policy and Administration from University of Southern California.





Dr Ghulam Muhammad Arif



Dr. Nayab has a PhD in Demography from the Australian National University (ANU), Canberra, Australia.




Dr Rashid Amjad

Abdul Wajid Rana



Research Activities at PIDE

Economists at PIDE also carry out research under intra-institutional or collaborative arrangements with several national and international organizations. Its research is globally acknowledged and RePEC (Research Paper in Economics) has ranked it among the top percent economic institutes in the world and 10th in Asia. The institute publishes its research in the form of books, working papers, monographs, journal articles, and research reports for academia and learned audience. LSE and in partnership with the University of Oxford, the IGC is majority funded by the UK Department for International Development (DFID). The IGC model is based on the recognition that building effective growth policies in developing countries requires more than imported solutions. Countries face a range of challenges that require new thinking, new evidence and a flow of new ideas.



International Food Policy Research Institute

The International Food Policy Research Institute (IFPRI) is an international agricultural research center founded in the early 1970s to improve the understanding of national agricultural and food policies to promote the adoption of innovations in agricultural technology. Additionally, IFPRI was meant to shed more light on the role of agricultural and rural development in the broader development

pathway of a country. The mission of IFPRI is to seek sustainable solutions for ending hunger and poverty through research. IFPRI carries out food policy research and disseminates it through hundreds of publications, bulletins, conferences, and other initiatives. IFPRI was organized as a District of Columbia non-profit, non-stock corporation on March 5, 1975 and its first research bulletin was produced in February 1976. IFPRI has offices in several developing countries, including

China, Ethiopia, and India, and has research staff working in many more countries around the world. Most of the research takes place in developing countries in Central America, South America, Africa, and Asia. IFPRI is part of a network of international research institutes funded in part by the CGIAR, which in turn is funded by governments, private businesses and foundations, and the World Bank.



Ministry of Planning, Development and Reforms

The Planning Commission (denoted as PC) is a financial and public policy development institution of the Government of Pakistan. The Commission comes under Ministry of Planning, Development and Reforms. The Planning Commission undertakes research studies and state policy development initiatives for the growth of national economy and the expansion of the public and state infrastructure of the country in tandem with the Ministry of Finance (MoF). Since 1952, the commission have had a major influence and role in formulating the highly centralized and planned five-year plans for the national economy, for most of the 20th century in Pakistan. Although the five-year plans were replaced by Medium Term Development Framework, the commission still played an influential and central role in the development of the programme. Furthermore, the Public Sector Development Programmes (PSDP) also placed under the domain of the planning commission. The commission's authoritative figures includes a Chairman who is the Prime Minister, assisted by the deputy chairman, and a science advisor.
